# House rules /Pub



# 1 Definitions

For the purpose of these rules, the following definitions apply:

- 1. The Foundation: the Foundation /Pub, established in Delft and registered at the Kamer van Koophandel under the number 74927337;
- 2. The Articles of Association: the Articles of Association of the Foundation, defined in a deed, signed on May 23rd 2019 at notary Westvest;
- 3. The Board: the Board of the Foundation, as mentioned in article 4 of the Articles of Association;
- 4. The visitor: the visitor of the /Pub.

## 2 General

- 1. The /Pub follows the house rules of the TU Delft, therefore, these regulations are applied in the /Pub.
- 2. These regulations apply at all times in the /Pub.
- 3. In cases where the situation is not foreseen by these regulations, the Board or the designated person responsible (appointed by the Board) decides.
- 4. The number of people in the /Pub will not exceed 157.
- 5. Payments in the /Pub must be done using a debit card or a /Pas.
- 6. Visitors are not allowed to wear clothing that can cause confusion with the /Pub Board clothing.

#### 3 Damage

- 1. Damage caused by a visitor, will be billed to the relevant visitor.
- 2. When a visitor causes damage, the relevant visitor agrees that the following personal data will be noted to process the damage: name, phone number, e-mail and student number.
- 3. The Foundation is not responsible for loss of or damage to personal goods.



## 4 Consumptions

- 1. The visitor is not allowed to bring or consume consumptions that were not purchased in the /Pub, unless one of the following exceptions applies:
  - (a) The visitor wants to have a complete meal. The /Pub only sells snacks, therefore it is allowed to order or bring your own meal and consume it in the /Pub.
  - (b) There is an event in the /Pub, which includes breakfast, lunch or dinner.
- 2. The visitor is not allowed to bring consumptions or glassware outside the /Pub.
- 3. Under no circumstances, is it allowed to consume hard liquor, spirits or any other alcoholic beverage with an alcohol percentage above 15%.

## 5 Privacy

- 1. When entering the /Pub, the visitor agrees to the following:
  - (a) Videos and photos can be taken of the visitor.
  - (b) The above mentioned visual material can be shared on the website and instagram account of the /Pub.
- 2. Videos and photos of the visitor shall not be shared with third parties without consent from the relevant visitor.
- 3. In case the visitor objects to taking and sharing visual material, the visitor can contact the Board.

## 6 Evacuation and fire safety

- 1. Activities in the /Pub shall not compromise the (fire) safety.
- 2. Upon activation of the fire alarm and/or the arrival of the fire brigade, caused by carelessness or such (false alarm), the relevant visitor will be charged EUR 635.
- 3. Evacuation can be led by the Board, the designated person responsible, officers of the municipality, faculty staff or the security of the TU Delft.
- 4. Instructions given by the barkeeper(s), the Board or another designated person responsible must be followed at all times.
